## WHAT DOES Bills.com, LLC DO WITH YOUR PERSONAL INFORMATION?

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>■ Social Security number and employment information</li> <li>■ account balances and transaction history</li> <li>■ credit history and assets</li> </ul>
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Bills.com, LLC chooses to share; and whether you can limit this sharing.

## Who we are

### Who is providing this notice?

Bills.com, LLC, a Delaware limited liability company that may use the name "Bills.com"

## What we do

### How does Bills.com protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

### How does Bills.com collect my personal information?

We collect your personal information, for example, when you

- Open an account with us or give us your account information
- provide employment info or provide account information
- give us your contact info

We may also collect your personal information from others, such as credit bureaus, affiliates or other companies.

### Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See Other Important Information section.

### What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to you alone unless you tell us otherwise.

## Definitions

### Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include Freedom Debt Relief, LLC, Freedom Financial Asset Management, LLC and Freedom Tax Relief, LLC*

### Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *We share with nonaffiliates in the categories of credit counseling agencies, loan broker and other financial service providers, insurance companies, mortgage providers and broker/dealers.*

### Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *We have no joint marketing partners i.*

**FOR CALIFORNIA RESIDENTS:** In accordance with California law, we will not share information we collect about you with nonaffiliates, except as allowed by law. For example, we may share information with your consent or to service your accounts. Among our affiliates, we will limit information sharing to the extent required by California law. You can also limit our sharing for joint marketing with other financial institutions. See the accompanying “Important Privacy Choices for Consumers – Additional Rights for California Residents.”

**FOR NEVADA RESIDENTS:** We are providing you this notice pursuant to state law. You may be placed on our internal "do not call" list by calling 800-544-7211. **FOR VERMONT RESIDENTS:** In accordance with Vermont law, we will not share information we collect about Vermont residents with companies who are not affiliates, except as permitted by law, such as with your consent or to service your accounts. We will not share information about your creditworthiness with our affiliates without your authorization or consent but we may share information about our transactions or experiences with your with our affiliates without your consent.

## Additional Rights for California Residents

### Important Privacy Choices for Consumers

**You have the right to control whether we share some of your personal information. Please read the following information carefully before you make your choices below.**

#### Your Rights

You have the following rights to restrict the sharing of personal and financial information with our affiliates (companies we own or control) and outside companies that we do business with. #### Your Choices
